The fund is a blend of institutional funds and mutual funds.

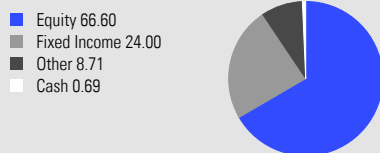

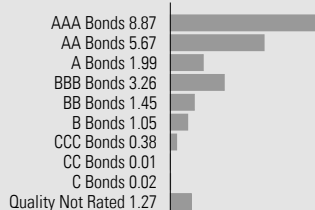

## Asset Allocation (%) as of 06/30/20

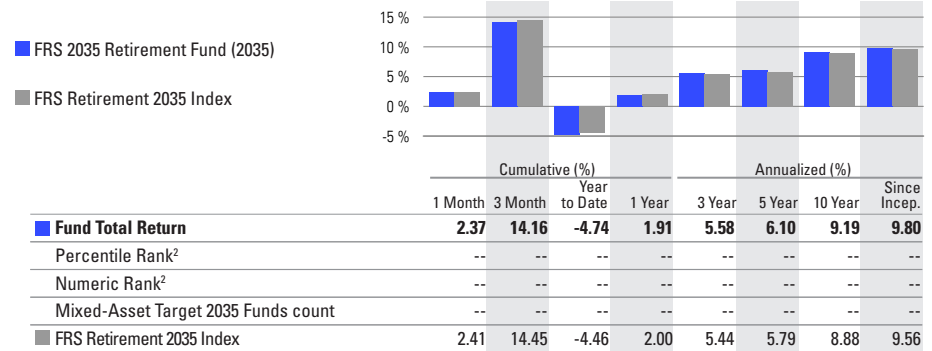

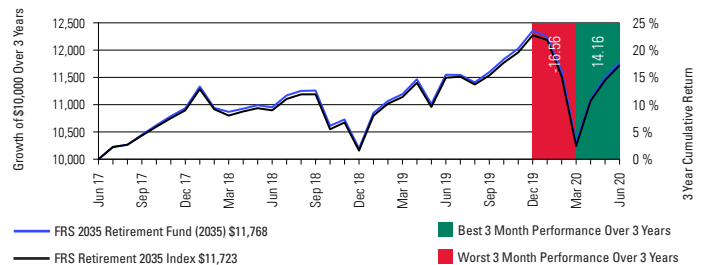

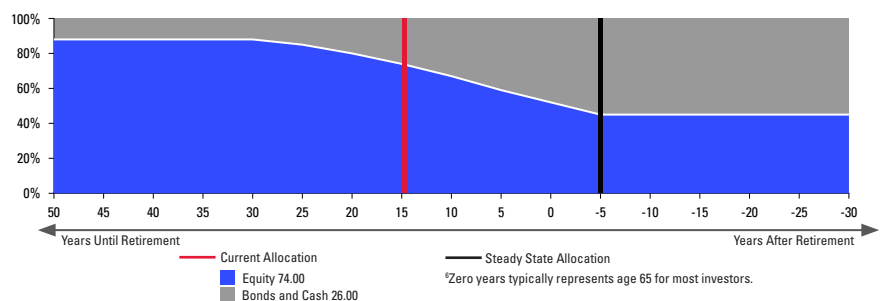

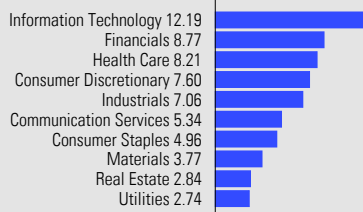

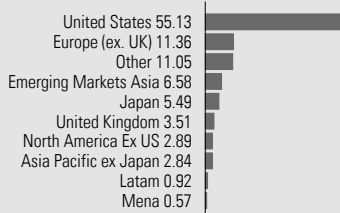
