The fund is a blend of institutional funds and mutual funds.

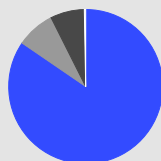

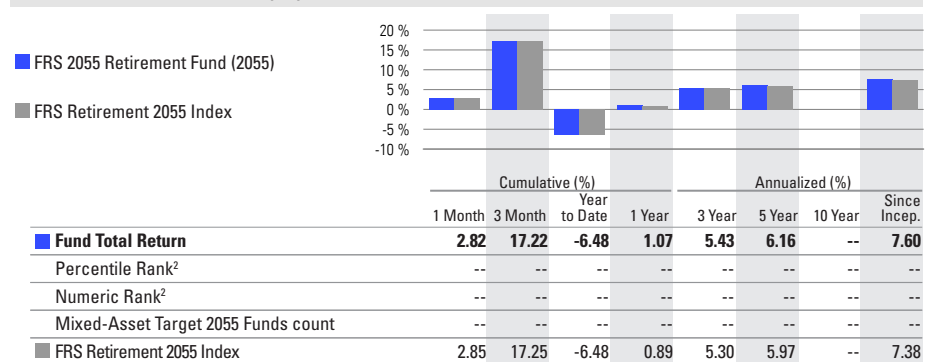

Historical Performance (%)

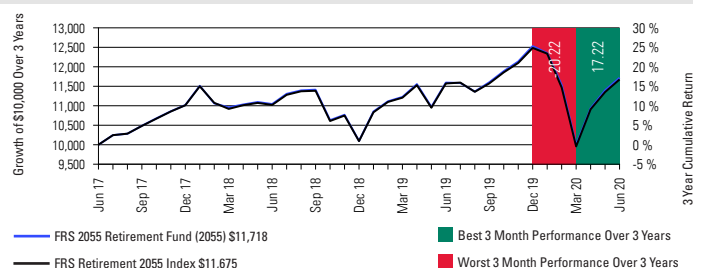

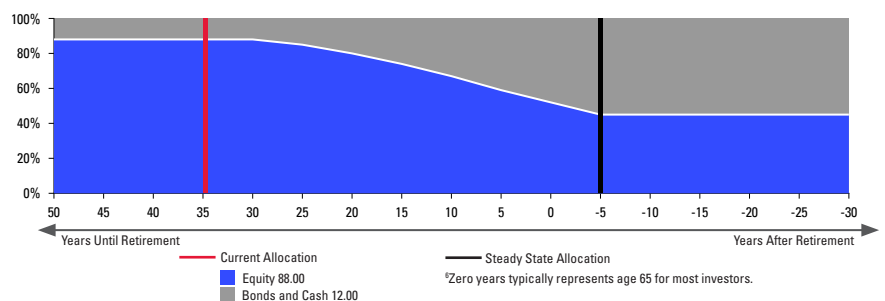

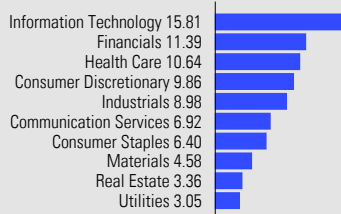

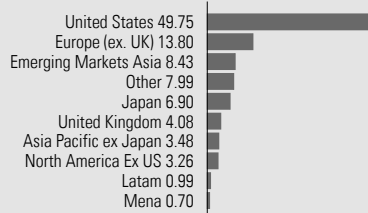
