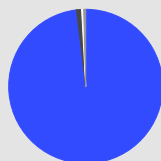

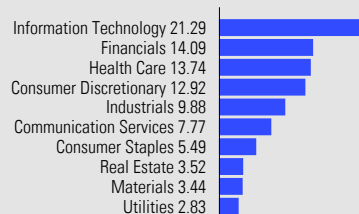

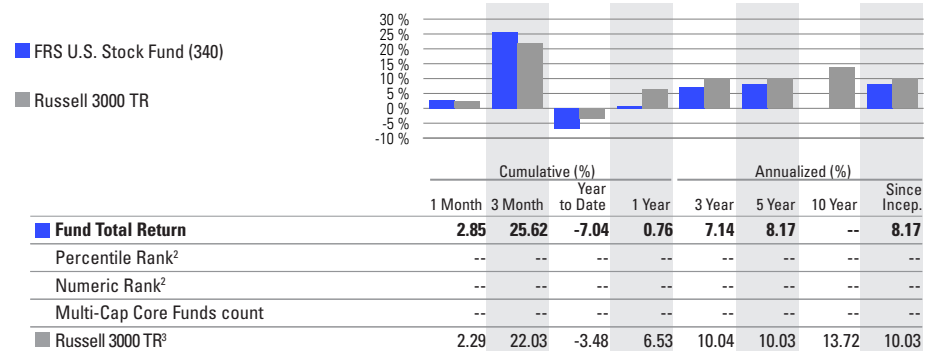

Historical Performance (%)



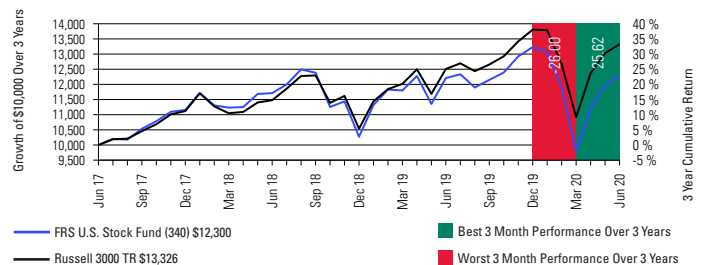
